2019 Synthetic Turf Field Use

Welcome to the City of Kent. Your group is scheduled to play on a Synthetic Turf Field. The field belongs to the citizens of Kent and is under the supervision of the Parks, Recreation and Community Services Department.

Synthetic Turf Fields require special consideration to maintain them in the best possible condition. The following rules are in place to preserve the integrity of the field and for the best interests of all users. We apologize for any inconvenience these rules may cause your group/team.

Users groups, verify all participants, coaches, athletes and their parent/guardian will follow the outlined facility rules as follows:

- > Failure to comply with all rules and regulations may jeopardize your group's future use of City of Kent Athletic Fields.
- League Coordinators, Presidents, Tournament/Event Directors, etc. are directly responsible for informing team managers, coaches, players and spectators of policies of field usage.
- > The City reserves the right to require additional insurance and/or additional fees depending on type of activity planned.
- > The City reserves the right to require police supervision for any event scheduled. Security requirements must be met and confirmed prior to your scheduled event. Cost of police supervision will be charged to field user.
- > Synthetic turf fields allows for play in most types of weather. However, the City reserves the right to close the fields due to extreme weather conditions (snow, ice, frozen ground, thunder/lightning, etc.) or field maintenance needs.
- > Users, its members, guests and invitees will show respect and sportsmanship toward City staff, officials, opposing team(s) and spectators.
- User groups must leave turf field in satisfactory condition (clean and free of damage). All litter and garbage must be disposed of properly. User groups damaging Park property will be held responsible for the cost of repair, replacement, or clean up.
- No shelled seeds of any kind will be allowed on turf fields, dugouts, bleachers, or around the field at any time before, during or after the event.
- > Turf shoes, tennis shoes, and rubber molded cleats are permitted on turf fields.

 METAL CLEATS/SPIKES ARE NOT PERMITTED ANYWHERE ON THE TURF FIELDS. NO EXCEPTIONS.
- Smoking, vaping or use of any tobacco products are prohibited on or near park property (including parking lots).
- Possession or consumption of alcoholic beverages on park property is strictly prohibited.
- Users, its members, guests and invitees, shall not solicit, sell or provide goods and/or services on the park premises, without written permission from the City of Kent Parks Department.
- The City of Kent Parks Maintenance Staff will complete all field maintenance.
- > Participants, children and spectators must be under the supervision of user group representative throughout the entire scheduled event.
- Parking is allowed in designated parking stalls or marked areas only. All vehicles improperly parked are subject to tow away at owners' expense.
- City of Kent is not responsible for loss, theft or damage to vehicles.
